

HIRE TERMS & CONDITIONS

WE DO NOT TAKE:

Fridges, Freezers, Tyres, Paint, Food Waste, Fluorescent Tubes, Mattresses, Corrugated Cement Fibre, Plasterboard

1. Payment falls due on delivery of skip except on approved credit accounts which must be settled within 30 days. Payments must be made before delivery for non-account customers.
2. Customers requesting and authorising vehicles to leave the public highway do so at their own risk and take full responsibility for any damage caused. This may include damage to driveways, underground services, manhole covers, paths, paving, overhead cables, gates and other items at the site of the producer of the waste.
3. All skips are hired on a 2 week period. Skips are automatically booked in for collection at the end of this 2 week period. The hire period may be extended at the user's request for a maximum of 2 extra weeks, at a charge of £20+ VAT per week over the 2 week hire period.
4. Skips must remain in the position left by the vehicle. The driver may decline to remove any repositioned skip if he feels damage may be caused to the skip lifting equipment. Wasted journeys will be charged to the user.
5. Access must be left at all times to the skip as wasted journeys will be charged to the user at £60.00+ VAT per visit.
6. No toxic substances must be placed within the skip. Please advise the driver of any items you are not sure about, such as batteries, gas cylinders, fridges or freezers, asbestos, plasterboard and rubber tyres. Any toxic substances that have to be returned to the hirer will be charged at £60.00+ VAT as we do not accept any of the above.
7. Plasterboard will not be accepted in general waste skips. A skip specifically for plasterboard can be purchased at a surcharge. If there is plasterboard in a general waste skip this can be collected by the customer, delivered back to the customer at a cost, or charged for disposal.
8. No fires must be lit within the skip or in close proximity as resulting damage will be charged at the cost of a new skip.
9. Any damage caused to the skip will be charged to the hirer. This includes repairs and re-painting.
10. Skips must be safely loaded and material kept within the confines of the skip. If the skip is overloaded the driver will, at his discretion, either refuse to remove the skip or wait until the load is corrected. Waiting time will be charged at £30.00+ VAT for 1/2 hour or part thereof. A further skip for the surcharge waste can be ordered at the current rate.
11. Times of collection will be entirely at our discretion. If a definite pick up is required on a specific day this can be requested but no guarantee can be given.
12. The user will have no further title to any items deposited in the skip once removal has been effected and any items become property of Banbury Plant Hire.
13. In the event that payment in full or part is not received for the skip then Banbury Plant Hire may return the skip contents to the site of collection. The contents will be of the same nature as that removed, ie, either inactive or active waste.
14. Hire Terms & Conditions for placing skip on a highway:- The skip hirer becomes the skip 'owner' and takes sole responsibility for the provision of lamps, cones & lighting. It is the hirer's responsibility to notify Banbury Plant and Skip Hire if a permit needs renewing, with at least 6 working days notice.

The Waste Hierarchy

Stages

Includes

Prevention



Using less material in design and manufacture.
Keeping products for longer; re-use.
Using less hazardous material.

Preparing for re-use



Checking, cleaning, repairing, refurbishing, repair, whole items or spare parts.

Recycling



Turning waste into a new substance or product including composting if it meets quality protocols.

Other
recovery



Including anaerobic digestion, incineration with energy recovery, gasification and pyrolysis which produce energy (fuels, heat and power) and materials from waste, some backfilling operations.

Disposal



Landfill and incineration without energy recovery.
